ASSIGNMENT OF OIL AND GAS LEASE

Whereas, on the 14th day of July, 1954, a certain oil and gas mining lease was made and entered into by and between Charles E. Singletary and Ruth Singletary, his wife, lessor, and Robert W. Sievers, lessee, covering the following described land in the County of Sublette, State of Wyoming, to-wit:

Whereas, the said lease and all rights thereunder or incident thereto are now owned by said Robert W. Sievers.

Now, therefore, for and in consideration of One Dollar (and other good and valuable considerations), the receipt whereof is hereby acknowledged, the undersigned, the present owner of the said lease and all rights thereunder or incident thereto, does hereby bargain, sell, transfer, assign and convey unto Belco Petroleum Corporation, of 42 Broadway, New York City, New York, all right, title and interest of the original lessee and present owner in and to the said lease and rights thereunder in so far as it covers all of the above described lands.

And for the same consideration, the undersigned, for himself and his heirs, successors and representatives, does covenant with the said assignee, or its assigns that he is the lawful owner of the said lease and rights and interests thereunder; that the undersigned has good right and authority to sell and convey the same, and that the said rights, interest and property are free and clear from all liens and incumbrances, and that the undersigned will warrant and defend the same against the lawful claims and demands of all persons whomsoever.
