KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, under date of JULY 2, 1951, the
STATE OF WYOMING issued that certain oil and gas lease bearing serial number

WHEREAS, J. E. CHEEK is the present owner and holder of a
FIVE percent (5 %) overriding royalty interest in and to all of the
oil, gas and other hydrocarbon substances, produced, saved and sold from the said lands,
under and pursuant to said Oil and Gas Lease.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00)
and other good and valuable consideration, the receipt of which is hereby acknowledged,
J. E. CHEEK does hereby set over, transfer and assign unto ARTHUR B. BELFER,
an undivided FIVE percent (5 %) overriding royalty interest in
and to all of the oil, gas and other hydrocarbon substances, produced saved and sold from
the aforesaid lands, under and pursuant to said Oil and Gas Lease.

For the above cited consideration, the said J. E. CHEEK does hereby
set over, transfer and assign unto ARTHUR B. BELFER, all his right, title and
interest, of every kind and character, which the said J. E. CHEEK owns or con-
trols in connection with the above described lands, including, but not limited to, any
overriding royalties he may control in excess of the above cited overriding royalty and
any and every right of reversion in said lands.

This Assignment shall inure to and bind the parties hereto, their heirs,
successors, administrators, executors and assigns.
