NOW, THEREFORE, in consideration of the sum of \$10.00 and other good and valuable consideration, the receipt of which is hereby acknowledged, WYOMING PETROLEUM CORPORATION does hereby set over, transfer and assign unto ARTHUR B. BELFER, subject to the approval of the Secretary of the Interior, an undivided 1/4 of 1 % overriding royalty interest in and to the oil, gas and other hydrocarbon substances, produced, saved and sold from the aforesaid lands, under and pursuant to said Oil and Gas Lease.

THIS ASSIGNMENT shall inure to and bind the parties hereto, their heirs, successors, administrators, executors and assigns.
