

ASSIGNMENT OF ROYALTY

KNOW ALL MEN BY THESE PRESENTS: That Thomas Paul Facinelli and Gazell Facinelli,
husband and wife, and Victor John Facinelli and Joan Facinelli, husband and wife,
of Rock Springs, Sweetwater County, Wyoming, for and in consideration of the sum of

Ten and No/100 (\$10.00) - - - - - Dollars,

and other good and valuable considerations, in hand paid by Ben. E. Fowler and Rita J. Fowler,
of Rock Springs, Sweetwater County, Wyoming hereinafter called assignee, the receipt of which is
hereby acknowledged and confessed, do hereby sell, assign, transfer, convey and set over unto the said
assignee, all of our right, title, and interest in and to six and one-fourth

Per Cent (6 1/4 %) Royalty of all of the oil and of all the gas produced and saved from the herein-
after described lands, located in the County of Sublette, State of Wyoming, to-wit:

In Township 33 North, Range 108 West of the Sixth Principal Meridian, Wyoming:

Section 18: Lots 3 and 4, E 1/2 SW 1/4

Section 19: Lots 1 and 2, E 1/2 NW 1/4

In Township 33 North, Range 109 West of the Sixth Principal Meridian, Wyoming:

Section 13: E 1/2 SW 1/4, SE 1/4

Section 24: NE 1/4

Reserving, nevertheless, to the Grantors, their heirs, administrators, and assigns,
any and all delay and other rentals which shall accrue from or become payable on
account of any and all oil and gas leases, and the sole right to negotiate, enter into
and execute oil and gas leases covering said lands.

and embracing _____ acres, more or less, according to the Government official survey thereof:

This is an overriding royalty and is given by the grantor and accepted by the grantee, subject to the
terms and provisions in the original lease or leases on said land as now in force and effect;

TO HAVE AND TO HOLD unto the said assignee, his heirs, administrators, and assigns said royalty as
above set forth, the said oil and gas so produced and saved from said lands to be delivered free of cost to the
royalty owner in the pipe lines serving said premises or tanks erected thereupon for the purpose of storing
such products, together with the rights, privileges and benefits to be derived therefrom; and I do hereby
assign said royalty under the lease now covering said lands, ~~and agree to warrant and defend the title to~~
~~the same and that I have lawful authority to sell and assign said royalty.~~

The assignor reserves the right (and it is agreed to by the assignee) to sell and dispose of the royalty
oil or gas above conveyed to the purchaser or purchasers of his own oil or gas, subject to proper accounting
for the proceeds thereof to the assignee herein named.
