

ASSIGNMENT OF OPERATING AGREEMENT

WHEREAS, on the 26th. day of September, 1952, an operating agreement was entered into by and between WESTERN OIL REFINING COMPANY and PFAFF-QUEALY CORPORATION, whereby PFAFF-QUEALY CORPORATION was granted as such unit plan effects the "Shallow Zones". stratigraphic zone 1, 500 feet above the top of the Frontier Formation, with respect to the following described lands, an exact copy of said agreement, which was recorded on July 19, 1954, in book 10 & 11, page 172, Sublette County, Wyoming, being

14. FAIR EMPLOYMENT

Pfaff-Quealy shall not discriminate against any employee or applicant for employment because of race, creed, color or national origin, and shall require an identical provision to be included in all sub-contracts.

15. RESERVATION TO THE UNITED STATES

The parties hereto hereby consent as to the lands of the United States, to a reservation to the United States, pursuant to the provisions of the Act of August 1, 1946 (Public No. 585, 79th Congress) of all uranium, thorium and other materials which are or may be determined to be peculiarly essential to the production of fissionable materials, whether or not of commercial value, together with the right of the United States, through its authorized agents or representatives, at any time to enter upon the land and prospect for, mine and remove same.

16. APPROVAL DEPARTMENT OF THE INTERIOR

This agreement is subject of the approval of the Department of the Interior.
