a total of 3/4 of 1% overriding royalty interest in and to the oil, gas and other hydrocarbon substances, produced, saved and sold from the aforesaid lands, under and pursuant to said Oil and Gas Lease.

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Margaret L. Justheim and Merin Morgan do hereby set over, transfer and assign unto the WYOMING PETROLEUM CORPORATION, subject to the approval of the Secretary of the Interior, and undivided 3/4 of 1% overriding royalty interest in and to the oil, gas and other hydrocarbon substances, produced, saved and sold from the aforesaid lands, under and pursuant to said Oil and Gas Lease.

This Assignment shall inure to and bind the parties hereto, their heirs, successors, administrators, executors and assigns.
