Now, Therefore, For and in consideration of One Dollar, [and other good and valuable considerations,] the receipt of which is hereby acknowledged, the undersigned, the present owner of the said lease and all rights thereunder or incident thereto, dos hereby bargain, sell, transfer, assign and convey unto Continental Oil Company, a Delaware corporation; Malco Refineries, Inc., a New Mexico corporation; El Paso Natural Gas Company, a Delaware corporation all of its right, title and interest of the original lessee and present owner in and to the said lease and rights thereunder, in so far as it covers the above described lands, together with all of its right, title and interest under the above described Agreement dated March 30, 1955, and


together with all personal property used or obtained in connection therewith to

Continental Oil Company, a Delaware corporation; El Paso Natural Gas Company, a Delaware corporation; Malco Refineries, Inc., a New Mexico corporation and their heirs, successors and assigns.

And for the same consideration, the undersigned for itself and its heirs, successors, and representatives, does covenant with the said assignee, _____ heirs, successors or assigns that it is the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due and payable thereunder have been duly paid.
