ASSIGNMENT OF ROYALTY  
INTEREST

KNOW ALL MEN BY THESE PRESENTS: That,

WHEREAS, the Western Oil and Refining Company assigned to Merin Morgan and Margaret Justheim on the 1st day of October, 1951, oil and gas lease Evanston 013494, covering the following described lands:

WHEREAS, said assignment was approved by the Bureau of Land Management on the 29th day of October, 1951, and

WHEREAS, Merin Morgan and Margaret Justheim are the present owners and holders of a one per cent (1%) royalty interest in and to said  $S\frac{1}{2}$  of Section 14, T. 29 N., R. 113 W., 6th P.M., Wyoming.

NOW, THEREFORE, in consideration of Twenty-five Hundred Dollars (\$2500.00) and other good and valuable consideration, receipt of which is hereby acknowledged, Merin Morgan and Margaret Justheim do hereby sell, assign and transfer to the Uintah-Wyoming Oil and Gas Company (a Utah corporation), a one half ( $\frac{1}{2}$ ) of one per cent (1%) overriding royalty interest in and to all oil and/or gas or other hydrocarbons produced, saved and sold from the aforesaid lands and subject to said oil and gas lease Evanston 013494.

This assignment shall inure to and bind the parties hereto, their heirs, successors, administrators, executors and assigns.
