ASSIGNMENT OF OIL AND GAS LEASE

THIS ASSIGNMENT, made this 21 day of September, 1951 by and between STANOLIND OIL AND GAS COMPANY, a Delaware Corporation, hereinafter called Assignor, and WHITE EAGLE OIL COMPANY, a Delaware Corporation, hereinafter called Assignee:

WITNESSETH:

For and in consideration of the sum of One Dollar (\$1.00) in hand paid by the Assignee to the Assignor, receipt thereof is hereby acknowledged, Assignor does hereby bargain, sell, convey, transfer, assign and set over unto Assignee, and its successors and assigns, an undivided one-half (1/2) interest in and to all of the right, title and interest, claim and demand of Assignor in and to that certain Oil and Gas Lease issued by the United States of America to H. J. Shad, which lease bears Serial No. Evanston 022931, and is dated November 1, 1947, insofar as it covers the following described land in the Counties of Lincoln and Sublette, State of Wyoming, to-wit:

THIS ASSIGNMENT is made without covenants of warranty either express or implied.

STATE OF *Wyoming* THIS ASSIGNMENT is made subject to all of the terms and provisions of the following agreements and Assignee does hereby agree that the rights acquired by it hereunder are in all respects subject to the terms and conditions of said agreements:

- (1) Unit Agreement for the development and operation of the East LaBarge Unit Area dated November 15, 1948, executed by Stanolind Oil and Gas Company as Unit Operator and working interest owner and by The Carter Oil Company, et al; as working interest owners and by L. C. Jarox, et al, as Royalty interest owners.
- (2) Unit Accounting agreement dated November 15, 1948, executed by Stanolind Oil and Gas Company as Unit Operator and working interest owner and The Carter Oil Company as working interest owner.
- (3) Letter agreement dated November 15, 1948, Re: East LaBarge Unit Agreement, Lincoln and Sublette Counties, Wyoming, by Stanolind Oil and Gas Company agreed to and accepted November 22, 1948 by The Carter Oil Company.

THIS ASSIGNMENT is made subject to the provisions of Section 30 (a) of the Act of Congress approved February 25, 1920, (41 Stat. 437) as amended by the Act of August 8, 1946, and shall take effect as of the first day of the lease month following the date of filing in the proper land office of three original executed counterparts hereof, together with any required bond and proof of the qualifications under said Act of the Assignee to take and hold this lease.
