ASSIGNMENT OF OIL AND GAS LEASE

THIS ASSIGNMENT, made this 26th day of March, 1951, by and between John S. Hutchins, hereinafter called Assignor, and STANOLIND OIL AND GAS COMPANY, hereinafter called Assignee:

WITNESSETH:

For and in consideration of the sum of One Dollar (\$1.00), ~~and other good and valuable considerations~~ in hand paid by the Assignee to the Assignor, receipt whereof is hereby acknowledged, Assignor does hereby bargain, sell, convey, transfer, assign and set over unto Assignee, and its successors and assigns, all of the right, title and interest, claim and demand of Assignor in and to that certain Oil and Gas Lease issued by the United States of America to John S. Hutchins, which lease bears Serial No. Evanston 022929, and is dated September 1, 1947, insofar as it covers the following described land in the County of Sublette, State of Wyoming, to-wit:

Containing 1920 acres, more or less.

And in consideration thereof Assignor warrants that he is the sole owner of any rights which may accrue under said lease and is the sole owner in law and equity of said lease through, by and under and by virtue of certain recorded instruments, and that said rights are free and clear of any liens or encumbrances or any outstanding conveyances or interests of any nature whatsoever, and that he has full right and lawful authority to sell and assign the same in the manner hereinabove described.

This assignment is made subject to the provisions of Section 30 (a) of the Act of Congress approved February 25, 1920 (41 Stat. 437) as amended by the Act of August 8, 1946, and shall take effect as of the first day of the lease month following the date of filing in the proper land office of three original executed counterparts hereof, together with any required bond and proof of the qualifications under said Act of the Assignee to take and hold this lease.
