Assignment of Oil and Gas Lease²⁶⁹⁵³

Excepting therefrom a parcel of land conveyed by Philetas P. Twitchell and Agnes I. Twitchell, his wife, to Earl M. Jones, by deed recorded in Book 24 of Deeds at Page 607, and described as follows, to wit:

Beginning at the section corner common to Sections 2 and 3, Township 26 North, Range 11 West of the Sixth Principal Meridian, thence South 89°50' West 435 feet; thence South 17°30' West 139 feet; thence South 48°50' West 100 feet; thence South 11°45' West 300 feet; thence South 26°15' West 400 feet; thence South 36°30' West 645 feet; thence South 84°47' East 1290 feet; thence North 0°4' East 1398 feet to the point of beginning, and containing 24.747 acres more or less, and

Beginning at a point 270 feet due South of the Northwest corner of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ on the Jones-Twitchell boundary fence, thence running South 32°30' West 530 feet; thence South 45°30' West 400 feet; thence South 20°45' West 1938 feet along Connors Creek to the County Road; thence South 58°0' East 1538 feet along the County Road; thence North 0°30' East 3355 feet to the point of beginning, and containing 55.244 acres more or less.
