Flower St., Los Angeles 54, California;

AND WHEREAS, it was the intention and desire of Phillips Petroleum Company to assign the undivided 60% interest covered by the above Assignment of April 17, 1956, to General Petroleum Corporation, instead of General Petroleum Company;

NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt whereof is hereby acknowledged, Phillips Petroleum Company does hereby bargain, sell, assign, and deliver unto General Petroleum Corporation, a Delaware Corporation, 612 South Flower Street, Los Angeles 54, California, its assigns and successors in interest, without warranty of title, either express or implied, an undivided 60% interest in the above described oil and gas lease, together with the same interest in all personal property and lease equipment of whatsoever nature situated thereon or appurtenant thereto or used in connection with the development and operation thereof for oil and gas mining purposes.

This assignment is executed in lieu of and in substitution for a prior assignment dated April 17, 1956, duly recorded in the records of Sublette County, Wyoming, in Book 15, Page 329, it being intended hereby to
