ASSIGNMENT OF ROYALTY INTEREST

WHEREAS, Albert E. Shaw is the present owner and holder of a 0.125 of 1 % overriding royalty interest in and to the oil, gas and other hydrocarbon substances, produced, saved and sold from the said lands, under and pursuant to said Oil and Gas Lease.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, Albert E. Shaw, does hereby set over, transfer and assign unto Ruth Shaw

subject to the approval of the Secretary of the Interior, an undivided 0.125 of 1 % overriding royalty interest in and to the oil, gas and other hydrocarbon substances, produced, saved and sold from the aforesaid lands, under and pursuant to said Oil and Gas Lease, divided as follows:

This Assignment shall inure to and bind the parties hereto, their heirs, successors, administrators, executors and assigns.
