ASSIGNMENT OF OIL AND GAS LEASE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned, THE CARTER OIL COMPANY, a corporation of the State of West Virginia, for and in consideration of the sum of ONE DOLLAR (\$1.00), the receipt of which is hereby acknowledged, and other valuable considerations, does hereby transfer, assign and deliver to BELCO PETROLEUM CORPORATION, New York, New York, subject to the reservations hereinafter set forth, all of its right, title and interest in and to a lease for oil and gas mining purposes covering land situate in SUBLETTE COUNTY, STATE OF WYOMING, and shown in the records in the office of the Register of Deeds in and for said County and State, to-wit:

Lease dated October 5, 1946, executed by William J. McGinnis, et ux, as lessors, recorded in Book 2 of Oil and Gas Leases, Page 109, as amended by separate instrument dated June 1, 1956, recorded in Book 15 of Oil and Gas Leases, Page 431, covering Tract 45 ($N\frac{1}{2} SE\frac{1}{4}$ of Section 23 and $N\frac{1}{2} SW\frac{1}{4}$ of Section 24) and Tract 47 ($S\frac{1}{2} NE\frac{1}{4}$ and $S\frac{1}{2} NW\frac{1}{4}$ of Section 24) Township 28 North, Range 113 West.

Assignor expressly retains, saves and reserves from the operation of this assignment and unto itself, its successors and assigns, an overriding royalty of 1/8 of 8/8 of all oil, gas, casinghead gas and other minerals produced from said land under said lease. Assignor's reserved overriding royalty interest in all oil, gas, casinghead gas and other minerals produced from said land shall be delivered free of any expense to assignor.

This assignment is further subject to all of the terms, covenants and provisions contained in a certain agreement dated October 1, 1956, by and between the parties hereto, pertaining to the aforesaid lease and the development thereof, it being expressly agreed that said agreement is not merged herein.

This assignment is without warranty of title, express or implied.
