, subject to the approval of the Secretary of the Interior, an undivided 0.25 of 1 % overriding royalty interest in and to the oil, gas and other hydrocarbon substances, produced, saved and sold from the aforesaid lands, under and pursuant to said Oil and Gas Lease, divided as follows:

This Assignment shall inure to and bind the parties hereto, their heirs, successors, administrators, executors and assigns.

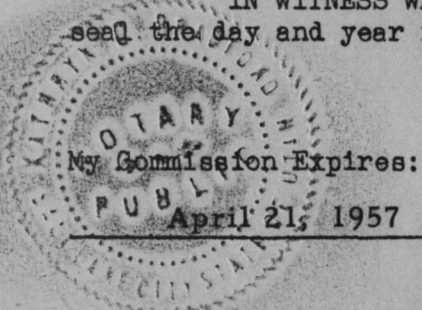
