

# ASSIGNMENT OF ROYALTY.

WHEREAS by a certain Oil and Gas Lease dated November 30, 1953, and of record in the office of the County Clerk of Sublette County, Wyoming, in Book 7, Oil & Gas Leases at page 222, Willard C. Spence and Glyndon Homer Spence, his wife, and Paul Logan Homer and Mildred Homer, his wife, the Lessors, conveyed and leased unto Belco Petroleum Corporation, the lessee, all the oil and gas in, underlying and which maybbe produced from from the following lands situate in the County of Sublette, State of Wyoming, to-wit;

Lots 2, 3 and 4 and SW $\frac{1}{4}$ NE $\frac{1}{4}$ , S $\frac{1}{2}$ NW $\frac{1}{4}$ , NW $\frac{1}{4}$ SE $\frac{1}{4}$  and SW $\frac{1}{4}$  of section 5, township 29 North, of Range 112 West of the 6th P. M. and other lands described in said lease to which reference is hereby made, for the primary term of five years from May 29, 1954,

but reserving unto the lessors one eighth of all oil and gas which may be produced and saved from said lands and delay rentals, and

Whereas said Lessors on October 10, 1957, sold and conveyed all the lands described in said lease unto Albert E. Schwabacher and May K. Schwabacher, his wife, of 100 Montgomery St., San Francisco, California, but excepting and reserving unto said Lessors two thirds of all said oil and gas and Lessors desire to transfer to said purchasers a one third of all rentals and royalties to accrue under said lease,

Now therefore, the said Lessors, for and in consideration of the premises, hereby bargain, sell, assign and set over unto said Albert E. Schwabacher and May K. Schwabacher, his wife, as tenants in common, a one third of all the royalties and rentals that may hereafter accrue and become due and payable by virtue of and under said lease and any renewal and extension thereof and direct and instruct said Belco Petroleum Corporation, its successors and assigns to pay to said Albert E. Schwabacher and May K. Schwabacher, their heirs, devisees, representatives and assigns, said one third of said rentals and royalties when and as due.
