ASSIGNMENT OF OVERRIDING ROYALTY

KNOW ALL MEN BY THESE PRESENTS THAT:

WHEREAS, the undersigned, John L. Kemmerer, Jr., is the record owner of that certain oil and gas lease issued by The United States of America dated September 1, 1947, bearing Serial No. Evanston 022929 and describing the following lands situated in the County of Sublette, State of Wyoming, to-wit:

Section 35: All

NOW, THEREFORE, for and in consideration of the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable considerations in hand paid by Max L. Krueger and Aliene W. Krueger of 1500 Grand Avenue, Laramie, Wyoming, as tenants in common, hereinafter called "Assignee," the receipt and sufficiency of which is hereby acknowledged by John L. Kemmerer, Jr., herein-after called "Assignor," Assignor has sold, assigned, transferred, and conveyed, and by these presents does sell, assign, transfer, and convey unto Assignee one-half of one per cent ( $1/2$  of 1%) of all oil, gas, casinghead gas, and other hydrocarbon substances which may be produced and saved from the premises hereinabove described under and pursuant to the terms of the said oil and gas lease.

TO HAVE AND TO HOLD unto Assignee, their heirs, personal representatives, successors, and assigns.

Assignor agrees to execute such further instruments and assurances of title as Assignee may reasonably request, to properly vest in Assignee the title to the overriding royalty interest hereby transferred and assigned.

Assignor hereby represents and covenants that he is the lawful owner of the interest hereby transferred and assigned; that he has full right and authority to transfer and assign the same; that said interest is free and clear of all liens and encumbrances; and that he will warrant and forever defend the same against the lawful claims and demands of all persons whomsoever.
