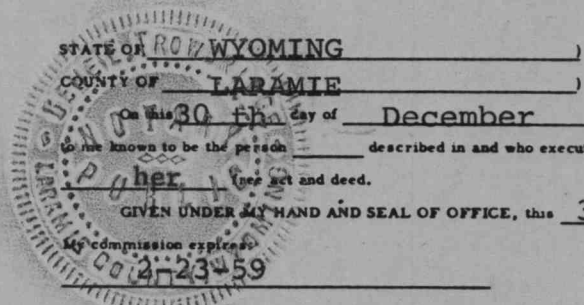
This Ratification and Joinder of Unit Agreement shall be binding upon the undersigned, his heirs, devisees, executors, assigns, or successors in interest.
