ASSIGNMENT OF OIL AND GAS ROYALTY

THIS AGREEMENT, made and entered into on the 26th day of March, A.D., 1958 by and between A. Hazel McKenna hereinafter called Assignor and John P. Dever of Box 2162, Cheyenne, Wyoming, hereinafter called Assignee;

WITNESSETH:

That the undersigned Assignor, for and in consideration of the sum of Ten and no/100 Dollars (\$10.00), and other good and valuable considerations to her in hand paid by said Assignee, the receipt whereof is hereby confessed and acknowledged, does hereby SELL, ASSIGN, TRANSFER, SET OVER and CONVEY unto said Assignee, his heirs, personal representatives and assigns, an overriding royalty interest equal to Three-Fourths percent (3/4 of 1 %) of all of the oil, gas, natural gasoline, and other products obtained from gas, produced and saved from the following described lands under that certain oil and gas lease made and entered into by and between the United States and A. Hazel McKenna, as lessee, under date of June 1, 1956, bearing Wyoming Serial No. 039732 on the following described lands situated in Lincoln & Sublette County, State of Wyoming, to-wit:
