ASSIGNMENT OF OIL AND GAS LEASE

THIS ASSIGNMENT, made this 27th day of March, 1958, by

WITNESSETH:

FOR and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations in hand paid by the Assignee to the Assignor, receipt thereof is hereby acknowledged. Assignor does hereby bargain, sell, convey, transfer, assign and set over unto Assignee, and its successors and assigns, all of the right, title and interest, claim and demand of the Assignor in and to that certain Oil and Gas Lease issued by the United States of America to Ina J. Ausman, which lease bears Serial No. Wyo 055342 and is dated December 1, 1957, insofar as it covers the following described land in the County of Sublette, State of Wyoming, to wit:

Township 37 North, Range 112 West, 6th P.M.

AND in consideration thereof, Assignor warrants that she is the sole owner of any rights which may accrue under said lease and is the sole owner in law and equity of said lease through, by and under, and by virtue of certain recorded instruments, and that said rights are free and clear of any liens or encumbrances of any outstanding conveyances or interests of any nature whatsoever, and that she had full right and lawful authority to sell and assign the same in the manner hereinabove described.

THIS ASSIGNMENT is made subject to the provisions of Section 30 (a) of the Act of Congress approved February 25, 1920 (41 Stat. 437), as amended by the Act of August 8, 1946, and shall take effect as of the first day of the lease month following the date of filing in the proper land office of three original executed counterparts hereof, together with any required bond and proof of the qualification under said Act of the Assignee to take and hold this lease.
