DEED OF CONVEYANCE
 (Corporation)

THIS INDENTURE made this 18th day of April 1958, by and between WHITE ACORN SHEEP COMPANY, a corporation duly organized under the laws of the State of Wyoming, whose principal place of business is the City of ROCK SPRINGS, County of SWEETWATER, State of WYOMING, party of the first part and the STATE OF WYOMING, party of the second part,

WITNESSETH:

That, whereas, the said party of the first part is a corporation, duly incorporated and existing under and by virtue of the laws of the State of Wyoming, and in pursuance of the statutes in such case made and provided, has acquired and is the owner of certain coal, oil, gas and any minerals of any other character in, upon or under the following described lands:

SW₄¹NE₄¹:NW₄¹SW₄¹ Section 1, Township 29 North, Range 103 West; N₂¹S₂¹ Section 24; N₂¹NE₄¹:SE₄¹NE₄¹:SW₄¹SW₄¹ Section 27; SE₄¹SE₄¹ Section 33; NW₄¹NE₄¹ Section 34, Township 30 North, Range 103 West of the Sixth Principal Meridian, containing 480.00 acres more or less in Sublette County, Wyoming.

And Whereas, the Board of Directors or Trustees of said corporation duly assembled, duly passed the following resolutions: "It is resolved by the Directors or Trustees of WHITE ACORN SHEEP COMPANY that it is for the best interest of the said company to sell and convey to the State of Wyoming all of the coal, oil, gas and any minerals of any character in, upon or under the above described property together with the right of ingress and egress for mining purposes, for the consideration which the said company has heretofore received from the State of Wyoming, the same being the conveyance by the said State of Wyoming to the party of the first part of lands hereinbefore described, and Mary Bertagnolli, Vice-President, and Alfonso Bertagnolli Secretary of said WHITE ACORN SHEEP COMPANY, are hereby directed and authorized to make, execute and deliver for and in behalf of the said WHITE ACORN SHEEP COMPANY and as its act and deed to the said State of Wyoming a conveyance of all of the said company's rights, title and interest in and to all of the coal, oil, gas or any minerals of any other character in upon or under the above described lands, together with the right of ingress and egress into and upon and from the said premises, and to affix to the said conveyance, the corporate name and seal of said corporation."

NOW, THEREFORE, in pursuance of said resolution aforesaid, and in consideration of the conveyance to it by the State of Wyoming of a title to the above described lands, which conveyance by a good and sufficient deed, is hereby acknowledged to have been received, does by these presents grant, sell, demise, lease and forever quitclaim unto the State of Wyoming and to its successors and assigns all of its right, title and interest in and to all coal, oil, gas and all other minerals of whatsoever kind or character, in, upon or under the lands hereinbefore described, together with all dips, spurs and angles and also, all metals, ores, gold or silver-bearing quartz rock or earth therein, and all rights, privileges and franchises thereto incident, appendant and appurtenant or otherwise usually had and enjoyed and also, all and singular the tenements, hereditaments and appurtenances incident to or usually had and enjoyed in exploring or mining for any of the minerals or any coal or oil or gas which may abound in, upon or under the above described lands together with rights of ingress or egress for the full and complete enjoyment of the property hereby conveyed.

TO HAVE AND TO HOLD all and singular the said premises together with the appurtenances and privileges thereto incident unto the said State of Wyoming its successor or assigns forever.
