ASSIGNMENT OF OVERRIDING ROYALTY

KNOW ALL MEN BY THESE PRESENTS THAT:

WHEREAS, the undersigned, Ed Mosher, hereinafter called "Assignor", by virtue of an assignment dated the _____ day of _____, 1957, between Belfer Natural Gas Company and Ed Mosher, recorded in the office of the County Clerk of the County of Sublette, State of Wyoming, became the owner of a two and one-half per cent (2½%) overriding royalty in and to the oil and gas produced, saved and marketed from the lands therein described and as to the formations therein described pursuant to the terms and provisions of the oil and gas lease therein described.

NOW, THEREFORE, for and in consideration of the sum of Ten and no/100 and more (\$10.00) Dollars and other good and valuable consideration in hand paid by Max L. Campbell, Leona J. Campbell, Max L. Krueger and Aliene W. Krueger, hereinafter called "Assignee", the receipt and sufficiency of which is hereby accepted by Assignor, Assignor has sold, assigned, transferred and conveyed and by these presents does sell, assign, transfer and convey unto Max L. Campbell, Leona J. Campbell, Max L. Krueger and Aliene W. Krueger an undivided one-fourth (1/4) interest each, as tenants in common, as Assignee, all of his right, title and interest in and to a one and one-half per cent (1½%) overriding royalty in and to the oil and gas produced, saved and marketed from the lands hereinafter described and as to the formations hereinafter described all pursuant to the terms and provisions of the oil and gas leases hereinafter described, to-wit:

1. Oil and Gas Lease dated the _____ day of _____, 1957, from Selmer G. Larson, Receiver of the Bank of Paullina, Iowa, as Lessor, to Belfer Natural Gas Company, a Partnership, as Lessee, insofar and only insofar as said oil and gas lease covers all formations lying below the depth of Fifteen Hundred (1500) feet above the top of the Frontier Formation in and under the lands hereinafter described.

2. Oil and Gas Lease dated the 15th day of August, 1957, from Joseph A. Minton and Bessie B. Minton, husband and wife, as Lessors, to Belfer Natural Gas Company, a Partnership, as Lessee, insofar and only insofar as said oil and gas lease covers all formations lying below the depth of Fifteen Hundred (1500) feet above the top of the Frontier Formation in and under the lands hereinafter described.

Section 28: Northwest One-quarter of the Southeast One-quarter (NW¼SE¼), North One-half of the Southwest One-quarter (N½SW¼) and Southwest One-quarter of the Southwest One-quarter (SW¼SW¼).
