THIS AGREEMENT, made and entered into on the 2nd day of January, 1959, by and between GREEN RIVER BASIN CORPORATION, of Chicago, Illinois (a Wyoming Corporation with Certificate of Authority to transact business in Illinois), hereinafter called Assignor, and ROBERT V. NEW, of Chicago, Illinois, hereinafter called Assignee,

WITNESSETH:

That the undersigned Assignor, for and in consideration of the sum of Ten and no/100 Dollars (\$10.00), and other good and valuable considerations to it in hand paid by said Assignee, the receipt whereby is hereby confessed and acknowledged, does hereby SELL, ASSIGN, TRANSFER, SET OVER AND CONVEY unto said Assignee, his heirs, executors and assigns, overriding royalty interest in the amount of Four and One-sixth Per Cent (4-1/6%), payable out of all of the oil, gas and other hydrocarbons produced and saved from the following described Oil and Gas Lease, to-wit:

Lease dated April 5, 1958, executed by Arnold Olson also known as Arnold C. Olson, and Lena Olsen, husband and wife, as lessors, and Thomas F. Stroock, as lessee, recorded on June 4, 1958 in Book 20 Oil and Gas at Page 437 thereof, in the office of the County Clerk and Register of Deeds of Sublette County, Wyoming, and

Assignment of Oil and Gas Lease dated April 8, 1958 executed by Thomas F. Stroock and Marta F. Stroock, husband and wife, as Assignors, to Rocky Mountain Corporation, a Wyoming Corporation, Assignee, recorded on July 23, 1958 in Book 21 Oil and Gas at Page 264 thereof, in the office of the County Clerk and Register of Deeds of Sublette County, Wyoming, and

Assignment of Oil and Gas Lease dated August 8, 1958 executed by Rocky Mountain Corporation, a Wyoming Corporation, as Assignor, to Green River Basin Corporation, Assignee, recorded on September 4, 1958 in Book 21 Oil and Gas, at Page 464 thereof, in the office of the County Clerk and Register of Deeds of Sublette County, Wyoming, which Lease and Assignments cover the following described lands, to-wit:
