ASSIGNMENT OF ROYALTY

KNOW ALL MEN BY THESE PRESENTS, That Victor J. Facinelli, also known as V. J. Facinelli, and Joan Facinelli, husband and wife, of Sweetwater County, Wyoming, for and in consideration of the sum of Ten and No/100 (\$10.00) Dollars, in hand paid by Gazelle Facinelli, of Sweetwater County, Wyoming, hereinafter called assignee, the receipt of which is hereby acknowledged and confessed, do hereby sell, assign, transfer, convey, QUITCLAIM and set over unto the said assignee:

All of their right, title and interest in and to .75 of 1% royalty of all of the oil and all of the gas and other hydrocarbons produced and saved from such of the following described lands in which said Victor J. Facinelli, also known as V. J.
