## ASSIGNMENT OF OIL AND GAS ROYALTY

THIS AGREEMENT, made and entered into on this 2<sup>nd</sup> day of January, 1959,  
by and between Green River Basin Corporation, of Chicago, Illinois (a Wyoming Corporation with Certificate of Authority to transact business in Illinois), hereinafter called Assignor, and Robert V. New, of Chicago, Illinois, hereinafter called Assignee,

## WITNESSETH:

That the undersigned Assignor, for and in consideration of the sum of Ten and no/100 Dollars (\$10.00), and other good and valuable considerations to it in hand paid by said Assignee, the receipt whereby is hereby confessed and acknowledged, does hereby SELL, ASSIGN, TRANSFER, SET OVER AND CONVEY unto said Assignee, his heirs, executors and assigns, overriding royalty interest in the amount of Four and One-sixth Per Cent (4-1/6%), payable out of all of the oil, gas and other hydrocarbons produced and saved from the following described Oil and Gas Lease, to-wit:

Lease dated June 14, 1958, executed by Cornelia Baum Burke and Gordon T. Burke, her husband, and Harriett H. Baum, a Widow, as lessors to Thomas F. Stroock, as lessee, recorded on March 7, 1959 in Book 23 Oil & Gas, at Page 304 thereof, in the office of the County Clerk and Register of Deeds of Sublette County, Wyoming, and

Assignment of Oil and Gas Lease dated July 15, 1958, executed by Thomas F. Stroock and Marta F. Stroock, husband and wife, as assignors, to Green River Basin Corporation, a Wyoming Corporation, assignee, recorded April 17, 1959, in Book 23 Oil & Gas, at page 452 thereof, in the office of the County Clerk and Register of Deeds of Sublette County, Wyoming, which lesse and Assignment covers the following described lands, to-wit:
