ASSIGNMENT OF OIL AND GAS ROYALTY

THIS AGREEMENT, made and entered into on the 1st day of September, 1959, by and between GREEN RIVER BASIN CORPORATION, of Chicago, Illinois (a Wyoming Corporation with Certificate of Authority to transact business in Illinois), hereinafter called Assignor and ROBERT V. NEW, of Chicago, Illinois, hereinafter called Assignee,

WITNESSETH:

That the undersigned Assignor, for and in consideration of the sum of Ten and no/100 Dollars (\$10.00), and other good and valuable considerations to it in hand paid, by said Assignee, the receipt whereby is hereby confessed and acknowledged, does hereby SELL, ASSIGN, TRANSFER, SET OVER AND CONVEY unto said Assignee, his heirs, executors and assigns, overriding royalty interest in the amount of Four and One-sixth percent (4-1/6%), payable out of all of the oil, gas and other hydrocarbons produced and saved from the following described Oil and Gas Lease, to-wit:

Lease dated May 19, 1959, executed by Gaston Erramouspe and Grace Erramouspe, husband and wife, as lessors, to Thomas F. Stroock, as lessee, recorded on June 24, 1959, in Book 24 Oil & Gas, at Page 159 thereof, in the office of the County Clerk and Register of Deeds of Sublette County, Wyoming, and

Assignment of Oil and Gas Lease dated June 1, 1959, executed by Thomas F. Stroock and Marta F. Stroock, husband and wife, as Assignors, to Green River Basin Corporation, a Wyoming Corporation, Assignee, recorded on July 10, 1959 in Book 24 Oil and Gas, at Page 242 thereof, in the office of the County Clerk and Register of Deeds of Sublette County, Wyoming, which lease and assignment covers the following described lands, to-wit:
