## ASSIGNMENT OF OIL AND GAS ROYALTY

THIS AGREEMENT, made and entered into this 15<sup>th</sup> day of December, 1959, by and between GREEN RIVER BASIN CORPORATION, of Chicago, Illinois (a Wyoming Corporation with Certificate of Authority to transact business in Illinois), hereinafter called Assignor, and ROBERT V. NEW, of Chicago, Illinois, hereinafter called Assignee,

## WITNESSETH:

That the undersigned Assignor, for and in consideration of the sum of Ten and no/100 Dollars (\$10.00), and other good and valuable considerations to it in hand paid by said Assignee, the receipt whereby is hereby confessed and acknowledged, does hereby SELL, ASSIGN, TRANSFER, SET OVER and CONVEY unto said Assignee, his heirs, executors and assigns, overriding royalty interest in the amount of Four and One-Sixth Per Cent (4-1/6%), payable out of all of the oil, gas and other hydrocarbons produced and saved from the following described Oil and Gas Lease, to-wit:

Lease dated October 2, 1959 executed by Ruth E. Johnson, formerly Ruth E. O'Neil Witherspoon, an unmarried woman, as lessor, to Green River Basin Corporation, a Wyoming corporation, as lessee, recorded on December 2, 1959, in Book 25 Oil & Gas, at page 335 thereof, in the office of the County Clerk and Register of Deeds of Sublette County, Wyoming. Said lease covers the following described lands, to-wit:
