ASSIGNMENT OF OIL AND GAS ROYALTY

THIS AGREEMENT, made and entered into this 15th day of December, 1959, by and between GREEN RIVER BASIN CORPORATION, of Chicago, Illinois (a Wyoming Corporation with Certificate of Authority to transact business in Illinois), hereinafter called Assignor, and ROBERT V. NEW, of Chicago, Illinois, hereinafter called Assignee,

WITNESSETH:

That the undersigned Assignor, for and in consideration of the sum of Ten and no/100 Dollars (\$10.00), and other good and valuable considerations to it in hand paid by said Assignee, the receipt whereby is hereby confessed and acknowledged, does hereby SELL, ASSIGN, TRANSFER, SET OVER and CONVEY unto said Assignee, his heirs, executors and assigns, overriding royalty interest in the amount of Four and One-Sixth Per Cent (4-1/6%), payable out of all of the oil, gas and other hydrocarbons produced and saved from the following described Oil and Gas Lease, to-wit:

Lease dated September 23, 1959, executed by Arthur Lindback, also known as Olaf A. Lindback and Olaf Arthur Lindback, and Elizabeth Lindback, husband and wife, as lessors to Thomas F. Stroock, as lessee, recorded on October 23, 1959 in Book 25 Oil & Gas at page 258 thereof, in the office of the County Clerk and Register of Deeds of Sublette County, Wyoming, and

Assignment of Oil & Gas Lease dated October 2, 1959, executed by Thomas F. Stroock and Marta F. Stroock, husband and wife, as assignors to Green River Basin Corporation, a Wyoming corporation, assignee, recorded November 12, 1959, in Book 25 Oil & Gas, at page 285 thereof in the office of the County Clerk and Register of Deeds of Sublette County, Wyoming, which Lease and Assignment covers the following described lands, to-wit:
