WHEREAS: said David Fitzgerald executed an assignment of said lease and said lands to Belfer Natural Gas Company reserving to said David Fitzgerald an overriding royalty of 4%, together with a reversionary right, which was approved and became effective May 1, 1957, AND,

NOW, THEREFORE, for and in consideration of the sum of Ten and no/100 (\$10.00) and more Dollars and other good and valuable consideration in hand paid by Max L. Campbell, Leona J. Campbell, Max L. Krueger and Aliene W. Krueger, hereinafter called "Assignees", the receipt and sufficiency of which is hereby accepted by said David Fitzgerald, hereinafter called "Assignor", Assignor has sold, assigned, transferred and conveyed, and by these presents does sell, assign, transfer and convey unto Max L. Campbell, Leona J. Campbell, Max L. Krueger and Aliene W. Krueger an undivided one-fourth ( $\frac{1}{4}$ ) interest each, as tenants in common, in and to all of his right, title and interest in or under the following described oil and gas leases:
