If the Assignee should elect to surrender, let expire, abandon, release or relinquish all or any part of its rights hereunder, the Assignee shall notify the Assignor not less than sixty (60) days in advance of such surrender, expiration, abandonment, release or relinquishment and, if requested so to do by the Assignor, the Assignee immediately shall reassign such rights, or such part thereof, to the Assignor.
