WAIVER OF PRIORITY OF MORTGAGE LIEN

Jewett, does hereby except and release the working interest held under and by virtue of said Oil and Gas Lease from the lien under said mortgage, not waiving any of my rights under said mortgage as against the royalty interest in said mortgaged land, and agrees that the Oil and Gas Lease above mentioned shall have the same validity and effect as if executed, delivered, and recorded prior to the date of execution of the said mortgage above mentioned.


