PARTIAL SURRENDER OF OIL AND GAS LEASE

WHEREAS, under date of June 1, 1953, the Secretary of the Interior of the United States, pursuant and subject to the terms and provisions of the Act of Congress, approved February 25, 1920 (41 Stat. 437), as amended, issued that certain Oil and Gas Lease bearing Serial Number Wyoming-021479-A to Barry M. Sullivan covering the following described lands situated in Sublette County, State of Wyoming, to wit:

Township 27 North, Range 111 West
Section 15: N/2

Containing 320.00 acres, more or less.

WHEREAS, the above described Oil and Gas Lease was recorded in Book 28, on Page 636 of said County and State.

WHEREAS, Pan American Petroleum Corporation is the present owner and holder of said Oil and Gas Lease and all rents, royalties and other obligations due and payable under said lease have been duly paid to the United States of America, and there is not now due or owing any wages or monies to workmen employed in operations conducted on the above described lands, and the public interest will not be impaired if said lease is surrendered in its entirety; and full provisions for the conservation and protection of the said property have been made by the Lessee; and

WHEREAS, the present owner now desires to surrender to the United States of America, pursuant to the right of surrender contained in said lease, all of the above described lands.

NOW THEREFORE, for and in consideration of the premises, the undersigned, Pan American Petroleum Corporation, the present owner of said lease, does hereby surrender, release, assign and relinquish to the United States of America, all of its right, title and interest in and to the lands described above.


