

## RIGHT OF WAY CONTRACT

FOR AND IN CONSIDERATION OF THE SUM OF \$ 58.50, the receipt of which is hereby acknowledged,

Anderson L. McGinnis and Delia F. McGinnis, his wife; Walter C. Yose and Miranda Yose, his wife;  
John C. Budd and Lucille A. Budd, his wife; William J. McGinnis and Mamie McGinnis, his wife;  
~~Robert H. McGinnis and Viola McGinnis, a widow; Caroline M. Warner, a widow;~~

hereinafter referred to as Grantors (whether one or more), do hereby warrant and convey unto SERVICE PIPE LINE COMPANY, a Maine corporation, its successors and assigns, hereinafter referred to as Grantee, the right to construct, maintain, inspect, operate, protect, repair, replace, change the size of, or remove a pipe line or pipe lines, for the transportation of oil, gas, and the products thereof, on, over, and through the following described lands, of which Grantors warrant they are the owners in fee simple,

situated in Lincoln and Sublette County, State of Wyoming, to-wit:

Lot # 6 of Section 26; T. 26 N., R. 113 W., Lincoln County, Wyoming.

Tract h2 of Section 21, T. 28 N., R. 113 W., Sublette County, Wyoming.

together with the right of ingress and egress to and from said line or lines, or any of them, for the purposes aforesaid.

Should more than one pipe line be laid under this grant, at any time, an additional consideration, calculated on the basis of \$100.00 per lineal rod shall be paid for each line laid after the first line.

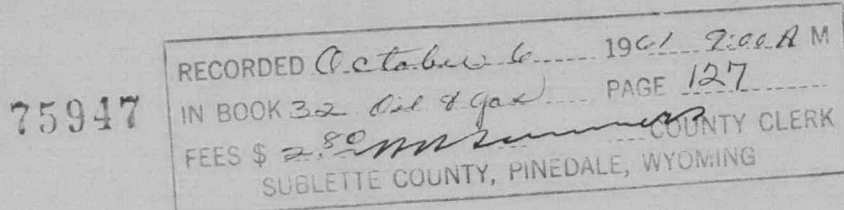
Grantors shall have the right to fully use and enjoy the above described premises, except as to the rights herein granted; and Grantors agree not to build, create, or construct, nor permit to be built, created, or constructed, any obstruction, building, engineering works, or other structure over said pipe line or lines. Grantee hereby agrees to pay any damages which may arise to growing crops, pasturage, fences, or buildings of said Grantors from the exercise of the rights herein granted, said damages, if not mutually agreed upon, to be ascertained and determined by three disinterested persons, one thereof to be appointed by Grantors, one by Grantee, and the third by the two so appointed, and the written award of such three persons shall be final and conclusive.

It is agreed that any payment due hereunder may be made direct to said Grantors or any one of them.

Any pipe line or lines constructed by said Grantee across lands under cultivation shall, at the time of construction thereof, be buried to such depth as will not interfere with such cultivation.

The rights herein granted may be assigned in whole or in part. Grantors hereby waive and release all rights under and by virtue of the homestead exemption laws of the State of Wyoming.

The terms, conditions, and provisions of this contract shall extend to and be binding upon the heirs, executors, administrators, personal representatives, successors, and assigns of the parties hereto.
