

AGREEMENT NOT TO DRILL

The undersigned, Belco Petroleum Corporation, the owner of certain mineral rights and surface rights in the lands hereinafter described by virtue of the terms and provisions of Federal Oil and Gas Leases, Wyoming 024469, Wyoming 053450, and Wyoming 024471, for and in consideration of the premises, One Dollar (\$1.00) and other valuable consideration, does hereby agree that neither Belco Petroleum Corporation nor its assigns will not during the term of the above described Oil and Gas Leases, or any extension or renewal thereof, of the above described Oil and Gas Leases, conduct drilling operations upon the following described lands, which in addition to other lands are covered by the above described Oil and Gas Leases, to-wit:

A portion of the NW $\frac{1}{4}$  of Section 21, Township 28 North, Range 112 West of the 6th Principal Meridian, Sublette County, described and bounded as follows:

Beginning at the SE corner of said Section 21; thence N 51° 41' 01" W for 4,610.23' to a point, said point being the center of the site; thence N 90° 00' 00" W for 300.00' to a point, said point being the true point of beginning; thence N 0° 00' 00" W for 300.00' to a point, thence S 90° 00' 00" E for 600.00' to a point; thence S 0° 00' 00" E for 600.00' to a point; thence N 90° 00' 00" W for 300.00' to a point; thence N 67° 30' 00" W for 229.61' to a point; thence N 22° 30' 00" W for 229.61' to the true point of beginning, containing 7.6593 acres, more or less, together with an easement for road purposes, 20 feet wide described as follows:

Leave U. S. Hwy 189, 8.7 miles north of LaBarge in SW $\frac{1}{4}$ NE $\frac{1}{4}$  Sec 27-T-28N-R112W. Proceed in a northwesterly direction through SW $\frac{1}{4}$ NE $\frac{1}{4}$  and NW $\frac{1}{4}$  Sec. 27 thence through NE $\frac{1}{4}$ NE $\frac{1}{4}$  Sec. 28, thence northerly through E $\frac{1}{4}$ SE $\frac{1}{4}$  Sec. 21 to the approximate center line of Sec. 21, thence westerly along center line of Sec. 21 approximately 1/4 mile, thence northerly through SW $\frac{1}{4}$ NE $\frac{1}{4}$ ; into E $\frac{1}{4}$ NW $\frac{1}{4}$  which is the site area.

THIS AGREEMENT will in no way affect Belco Petroleum Corporation's right of ingress and egress on the above described lands.
