

JOINT SURRENDER OF OIL AND GAS LEASE IN WHOLE

WHEREAS, under the date of July 1, 1953, the Secretary of the Interior of the United States, pursuant and subject to the terms and provisions of the Act of Congress, approved February 25, 1920 (41 Stat. 437), as amended, issued that certain Oil and Gas Lease bearing Serial Number W-021742 to Mary Malcolm, covering the following described lands situated in Sublette County, State of Wyoming, to wit:

Containing 2,560.00 acres, more or less.

WHEREAS, the above described oil and gas lease was recorded in Book 25, on Page 378 of said County and State.

WHEREAS, Pan American Petroleum Corporation and Colorado Oil & Gas Corporation are the present owners and holders of said Oil and Gas Lease and all rents, royalties and other obligations due and payable under said lease have been duly paid to the United States of America, and there is not now due or owing any wages or monies to workmen employed in operations conducted on the above described lands, and the public interest will not be impaired if said lease is surrendered in its entirety; and full provisions for the conservation and protection of the said property have been made by the Lessees; and

WHEREAS, the present owners now desire to surrender to the United States of America, pursuant to the right of surrender contained in said lease, all of the above described lands.

NOW THEREFORE, for and in consideration of the premises, the undersigned, Pan American Petroleum Corporation and Colorado Oil and Gas Corporation are the present owners of said lease, do hereby surrender, release, assign and relinquish to the United States of America, all of its right, title and interest in and to the lands described above.
