NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt of all of which is hereby acknowledged, Assignor does hereby grant, sell, transfer, assign, set over and convey unto Assignee all of Assignor's right, title, interest, privileges and benefits in said Oil and Gas Lease and in and to the leasehold estate created thereby and the said lands described therein, including all of the rights, benefits and privileges accruing to Assignor thereunder, together with all of the operating rights of Assignor under said Oil and Gas Lease.

Assignor does hereby specifically retain and reserve, however, an overriding royalty over and above all royalties available to the United States of America under said lease in an amount equal to ~~One~~ ^{One & One-Half} ~~One~~ ^(1 1/2) Per Cent ~~XX~~ ^{XX} of the value of all oil, gas and other hydrocarbon substances produced, saved and sold from the ~~lands~~ ^(1 1/2) lands and not used by Assignee in its operations thereon. The ~~One~~ ^{One & One-Half} ~~One~~ ^(1 1/2) Per Cent ~~XX~~ ^{XX} reserved royalty of Assignor shall only be payable in money, and Assignor shall not have the right to take such royalty in kind.

The value of Assignor's royalty shall be determined as hereinafter set forth:
