ASSIGNMENT OF  
 OVERRIDING ROYALTY INTEREST

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, under date of June 1, 1947, the United States of America issued that certain U. S. Oil and Gas Lease bearing Serial Number EVANSTON 022209, affecting certain lands in the County of Sublette, State of Wyoming, described as follows:

Township 28 North, Range 113 West, 6th P.M.  
 Section 33: SW $\frac{1}{4}$ NE $\frac{1}{4}$ , N $\frac{1}{2}$ SW $\frac{1}{4}$ , NW $\frac{1}{4}$ SE $\frac{1}{4}$ , Lots 1, 2, 3

and,

WHEREAS, Belco Petroleum Corporation is the present owner and holder of operating rights from the surface down to 1500 feet above the top of the Frontier formation in and to the oil, gas and other hydrocarbon substances produced, saved and sold from the said zone in the lands described hereinabove, under and pursuant to said oil and gas lease.

NOW, THEREFORE, in consideration of the sum of \$10.00, and other good and valuable consideration, the receipt of which is hereby acknowledged, Belco Petroleum Corporation does hereby set over, transfer and assign unto Western Oil Refining Company an undivided six percent of eight-eighths ( $\frac{6}{8}$  of  $\frac{8}{8}$ ths) overriding royalty interest in and to the oil and gas and other hydrocarbon substances produced, saved and sold from the aforesaid zones in the above-described lands, under and pursuant to the said oil and gas lease.

As further consideration for this Assignment, the acceptance hereof by Western Oil Refining Company shall constitute the acquiescence and agreement of Western Oil Refining Company that it will, at any time upon request of Assignor, commit the overriding royalty interest conveyed hereby to any Federal type unit agreement covering these lands.

Assignor agrees to execute such further instruments and assurances of title as Assignee may reasonably request to properly vest in Assignee the title to the overriding royalty interest hereby transferred and assigned.

Assignor hereby represent and covenants that it is the lawful owner of the interest hereby transferred and assigned; and that it has full right and authority to transfer and assign the same.

This Assignment shall inure to and bind the parties hereto, their successors and assigns.

IN WITNESS WHEREOF, this Assignment of Overriding Royalty Interest, effective as of June 1, 1962, has been executed this 28th day of May, 1962.
