WHEREAS, under date of May 13, 1955, the United States of America issued to E. R. Richardson its oil and gas lease designated as Wyoming Serial No. 033717, covering lands aggregating 2519.33 acres, more or less, in said Sweetwater and Sublette Counties, Wyoming, described as follows, to-wit:

all of which will more fully appear from said lease and the Records of the Bureau of Land Management, United States Department of the Interior, to which reference is hereby made for all purposes; and

WHEREAS, said lease and all rights, titles and interests connected therewith are now owned absolutely and exclusively by the undersigned E. R. Richardson;

NOW, THEREFORE, for and in consideration of the sum of Five Dollars and other good and valuable considerations to him in hand paid by Texas Pacific Coal and Oil Company, the receipt and sufficiency of which is hereby acknowledged, the said E. R. Richardson (sometimes hereinbelow called Assignor), does hereby bargain, sell, assign, convey and deliver unto said Texas Pacific Coal and Oil Company (a Texas corporation, with its principal office and place of business at Fort Worth, Texas), its successors and assigns, the above described oil and gas lease, together with all rights thereunder or incident thereto.

NEVERTHELESS, there is not conveyed hereby but there is expressly reserved to the said Assignor, his heirs and assigns, as a free overriding royalty, the value of two and one-half per cent (2 $\frac{1}{2}\%$ ) of all oil and gas which shall be produced, saved and marketed under the terms of said oil and gas lease and any extension thereof. The overriding royalty so reserved shall be paid to said Assignor free and clear of all development and operating costs at the mouth of the well or in the pipe lines to which the wells may be connected, as the case may be, payment therefor to be made in the same manner and at the same price paid for the royalty reserved by the United States of America in the base lease. The operator of said lease shall at all times be entitled to use production therefrom in the operation of the premises and the overriding royalty herein reserved shall be calculated only
