In the event Assignee shall desire to surrender all or any part of its right, title or interest herein, Assignee agrees to notify Assignor by registered mail at least 60 days in advance of any rental paying date and Assignor shall then have 15 days within which to elect to take a reassignment of the interest to be relinquished. Failure to elect to take reassignment within said 15-day period shall be deemed conclusive evidence that no reassignment is desired and Assignee may then be free to relinquish and surrender in any way that he or his successors in interest may deem fit. Should Assignor elect to obtain such a reassignment, same shall be delivered by Assignee by registered mail at least 15 days in advance of any rental paying date. Liability under the terms of this paragraph shall be limited to the amount paid for the original Option Agreement.
