

ASSIGNMENT OF OIL AND GAS LEASE

That the undersigned, Robert E. Skinner hereinafter called Assignor (whether one or more), for and in consideration of One Dollar (\$1.00) the receipt whereof is hereby acknowledged, does hereby sell, assign, transfer and set over unto:

Skinner, lessee recorded in book _____, page _____ insofar as said lease covers the following described land in Sublette County, State of Wyoming:

The Assignor herein hereby expressly excepts, reserves and retains title to an undivided 3% of all oil, gas and casinghead gas produced, saved, and marketed from the above described land under the provisions of the aforesaid lease, or any extension or renewal thereof, as an overriding royalty, free and clear of any cost and expense of the development and operation thereof, excepting taxes applicable to said interest and the production therefrom. In the event the lessors in said lease above described own less than the full and undivided mineral interest in any of the lands above described, the overriding royalty herein reserved shall be proportionately reduced as to such land.

All of the provisions of this assignment shall be available to and binding upon the respective heirs, executors, administrators, successors, and assigns of the Assignor and Assignee herein.
