ASSIGNMENT OF OVERRIDING ROYALTIES

THIS ASSIGNMENT of overriding royalties is made and entered into this *28th* day of *June*, 1963, by and between H. ORVILLE HOUSMANN, whose address is Post Office Box 28, Bakersfield, California, referred to herein as "Assignor", and BERNARD W. ALLEN and BETTY L. ALLEN, husband and wife, whose address is 2220 Mariposa Blvd., Casper, Wyoming, referred to herein as "Assignees".

W I T N E S S E T H:

Assignor, for and in consideration of the sum of Ten Dollars (\$10.00) and other value in hand paid to him by Assignees, the receipt and sufficiency of which is hereby acknowledged, does hereby bargain, sell, transfer and convey to Assignees all of his overriding royalty interest in and to those certain oil and gas leases issued by the United States of America, designated by the serial numbers below, insofar as said leases cover the lands herein described. The quantum of overriding royalty interest which Assignor believes he owns is set forth, but should Assignor own an overriding royalty interest greater than that set forth Assignor hereby transfers such greater overriding royalty to Assignees.
