WHEREAS, under date of January 1, 1950, the United States of America issued unto RETA WEINDEL, as Lessee, that certain U. S. Oil and Gas Lease bearing Serial Number Evanston 024470, affecting certain lands in the County of Sublette, State of Wyoming, described as follows:

containing 2560.00 acres, more or less, and,

WHEREAS, RETA WEINDEL, is the present owner and holder of a three per cent (3%) overriding royalty interest in and to the oil, gas and other hydrocarbon substances, produced, saved and sold from the said lands, under and pursuant to said Oil and Gas Lease, and

WHEREAS, this three per cent (3%) overriding royalty is the same overriding royalty referred to in the Assignment of Oil and Gas Lease Evanston 024470 dated September 9, 1952 from RETA WEINDEL to LAWRENCE RUBEN reserving 0.75 of 1% to Lessee, 1.125% to J. H. Morgan, Sr., 0.925 of 1% to Clarence I. Justheim, and 0.20 of 1% to Justheim Petroleum Company, and

WHEREAS, the 0.60 of 1% herein assigned to Morgan Gas & Oil Company (formerly Morgan (J. H.) Gas and Oil Company), is the same 0.60 of 1% transferred by J. H. Morgan, Sr. to Morgan (J. H.) Gas & Oil Company by royalty assignment dated March 26, 1959, and

WHEREAS, 0.64375 of 1% of the 0.84375 of 1% herein assigned to Justheim Petroleum Company, is the same 0.64375 of 1% transferred by C. I. Justheim to Justheim Petroleum Company by royalty assignment dated September 4, 1958.

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, RETA WEINDEL does hereby set over, transfer and assign to J. H. MORGAN, SR., MORGAN GAS & OIL COMPANY, CLARENCE I. JUSTHEIM and JUSTHEIM PETROLEUM COMPANY, subject to the approval of the Secretary of the Interior, an undivided two and one-fourth per cent (2.25%) overriding royalty interest in and to the oil, gas and other hydrocarbon substances, produced, saved and sold from the aforesaid lands, and under and pursuant to said Oil and Gas Lease, divided as follows:

J. H. Morgan, Sr.	- 0.525 of 1%
Morgan Gas & Oil Company	- 0.60 of 1%
Clarence I. Justheim	- 0.28125 of 1%
Justheim Petroleum Company	- 0.84375 of 1%

This Assignment of Royalty Interest is executed in confirmation of all previous assignments and shall inure to and bind the parties hereto, their heirs, successors, administrators, executors and assigns.
