PARTIAL SURRENDER OF OIL AND GAS LEASE

NOW THEREFORE, for and in consideration of the premises, the undersigned, Pan American Petroleum Corporation, the present owner of said lease, does hereby surrender, release, and relinquish all of its right, title and interest in and to the above referred to oil and gas lease insofar as it covers the above described land.
