

ASSIGNOR hereby does warrant and agree to forever defend all and singular the said lease and all rights and estate created thereby unto ASSIGNEE against every person whomsoever lawfully claiming or to claim the same or any part thereof; and ASSIGNOR further covenants and warrants that ASSIGNOR is the sole owner of said lease and all of the leasehold rights which it purports to create and has full right to assign and convey the same, subject only to the approval of the Secretary of the Interior; and that said lease is in full force and effect as to the lands above described and is not subject to cancellation or termination from any cause; that all rentals and royalties due thereunder have been paid; and that said lease and all substances which may be produced thereunder are free and clear of all liens, charges, encumbrances, overriding royalties, operating or other interests of any nature, excepting only the royalties provided therein and two and one-half percent (2 1/2%) *✓*
