

ROYALTY ASSIGNMENT

WITNESSETH:

The undersigned assignor for and in the consideration of the sum of \$10.00 and other good and valuable considerations to assignor in hand paid by said assignee, the receipt whereof is hereby confessed and acknowledged, does hereby sell, assign, transfer, set over and convey unto said assignee, heirs, personal representatives (or its successors) and assigns, an overriding royalty equal to One and one-half percent (1 1/2%)


