

# ROYALTY ASSIGNMENT

This assignment made and entered into this 3rd day of June, 1966, by and between CURTIS J. LITTLE and wife, ANNE B. LITTLE

## WITNESSETH:

The undersigned assignor for and in the consideration of the sum of \$10.00 and other good and valuable considerations to assignor in hand paid by said assignee, the receipt whereof is hereby confessed and acknowledged, does hereby sell, assign, transfer, set over and convey unto said assignee, heirs, personal representatives (or its successors) and assigns, an overriding royalty equal to One and one-half percent (1½%)

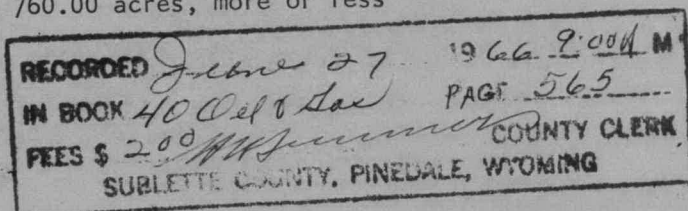
of the market value at the wells as produced of all of the oil and gas and other hydrocarbon substances which may be produced, saved and marketed from the following described lands situated in the County of Sublette,
