Slingerland, hereinafter called "Assignor," Assignor has sold, assigned, transferred, and conveyed, and by these presents does sell, assign, transfer, and convey unto Assignee four and three-quarters percent (4 3/4%) of the aforementioned overriding royalty, and being four and three-quarters percent (4 3/4%) of all oil, gas, casinghead gas, and other hydrocarbon substances which may be produced and saved from the premises hereinabove described under and pursuant to the terms of the oil and gas lease issued, or which may be issued, pursuant to the application hereinabove mentioned.

TO HAVE AND TO HOLD unto Assignee, his heirs, personal representatives, successors, and assigns, subject, however, to all of the terms and conditions of the aforementioned agreement and/or assignment.

Assignor agrees to execute such further instruments and assurances of title as Assignee may reasonably request, to properly vest in Assignee the title to the overriding royalty interest hereby transferred and assigned.

Assignor hereby represents and covenants that she is the lawful owner of the interest hereby transferred and assigned; that she has full right and authority to transfer and assign the same; that said interest is free and clear of all liens and encumbrances; and that she will warrant and forever defend the same against the lawful claims and demands of all persons whomsoever.
