ASSIGNMENT OF OIL AND GAS LEASE

KNOW ALL MEN BY THESE PRESENTS that we, John J. Rilinger, a single person, of Corning, Kansas, and Richard T. Rilinger and his wife, Hila Rilinger, of Baileyville, Kansas, for and in consideration of Ten and No/100 (\$10.00) Dollars and other valuable consideration, in hand paid, the receipt whereof is hereby confessed and acknowledged, do hereby grant, bargain, sell, assign, transfer and convey to John M. Sulenta and Harold Reach of Pinedale, Wyoming, any and all right, title and interest which we, or any of us, have, or shall hereafter acquire, as heir at law of Felix Walter Rilinger, deceased, or as distributee of the estate of said Felix Walter Rilinger, deceased, in and to that certain oil and gas lease, dated April 6, 1967, made and entered into by and between said Felix Walter Rilinger as lessor and Erving Wolf, 308 Lincoln Tower Building, Denver, Colorado, as lessee, covering the following described lands:

Township 33 North, Range 109, West of the Sixth Principal Meridian:

Section 23: That portion of $SE\frac{1}{4}$ and the $NE\frac{1}{4}SW\frac{1}{4}$ lying and being situate north of U. S. Highway 187, less a tract of 73.81 acres in $E\frac{1}{2}SE\frac{1}{4}$ described as follows: Beginning at the southeast corner of the said Sec. 23 where is found a blue granite stone 7" x 5" x 6" above ground marked - on E and = on S with pits in each section and mound of earth; thence S $89^{\circ} 59'$ W, 660.0 feet along the south line of said Sec. 23 to a point; thence N $36^{\circ} 07'$ W., 1113.1 feet to a point on the west line of the said $E\frac{1}{2}SE\frac{1}{4}$; thence N $00^{\circ} 04'$ E, 1765.0 feet along the west line to the northwest corner of the said $E\frac{1}{2}SE\frac{1}{4}$; thence South $89^{\circ} 59'$ East, 1318.7 feet along the north line of the said $E\frac{1}{2}SE\frac{1}{4}$ to the east one-quarter corner of said Sec. 23 which is as described on the map for the South Bench Road of record in the office of the Clerk of Sublette County, Wyoming; thence South $00^{\circ} 06'$ W, 2663.1 feet along the east line of said Sec. 23, to the point of beginning;

Section 26: $NE\frac{1}{4}$, less that portion of the $SW\frac{1}{4}NE\frac{1}{4}$ described as follows: Beginning at a point 100 feet east of the southwest corner of $SW\frac{1}{4}NE\frac{1}{4}$ of said Section 26; thence running 100 feet west along the quarter section line; thence 100 feet north along the quarter section line; thence in a southeasterly direction to the point of beginning;

which lease was filed for record in the office of the County Clerk and Ex-Officio Register of Deeds within and for Sublette County, Wyoming, on the 31st day of May, 1967, and duly recorded in Book 41 of Oil and Gas Leases, Page 320;

TO HAVE AND TO HOLD the same unto the said John M. Sulenta and Harold Reach, their heirs, devisees and assigns forever.

This assignment is granted subject to the terms and provisions of said lease as now in force and effect.
