KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, reference is made to that certain Unit Agreement and Unit Operating Agreement each dated June 18, 1969, for the development and operation of the Game Hill Unit Area, the Unit Agreement being of record in Book 3 at Page 31 of the Records of Teton County and in Book 42 at Page 580 of the Records of Sublette County, Wyoming, covering lands in said Counties and State as particularly described in said Unit Agreement, a copy of which has been delivered to the undersigned; and

WHEREAS, the undersigned, whether one or more, represent that they own the working, royalty, overriding royalty, or other oil and gas interests in lands within said Unit Area which are scheduled in Exhibit "B" to said Unit Agreement as being owned by them, and desire to commit such interests, and any other interest of the undersigned in said Unit Area, to such Unit Agreement and Unit Operating Agreement.

NOW, THEREFORE, in consideration of the advantages to be derived from unit operations and in further consideration of the mutual covenants and agreements of the parties thereto in said Unit Agreement and Unit Operating Agreement contained, the undersigned hereby severally, each to the extent of his particular interest, ratify, confirm, and adopt the aforesaid Unit Agreement and Unit Operating Agreement and agree to be fully bound thereby in the same manner and with the same force and effect as though each of the undersigned had duly executed each such agreement, and agree and consent to the inclusion in said Unit Agreement and Unit Operating Agreement of all right, title and interest of the undersigned in working, royalty, overriding royalty, or other oil and gas interests in said Unit Area, whether or not such interest is scheduled in Exhibit "B" to said Unit Agreement and hereby fully commit to such Unit Agreement and Unit Operating Agreement all interests of any nature whatsoever of the undersigned in said Unit Area.
