ASSIGNMENT OF OVERRIDING ROYALTY INTEREST IN

Whereas, Lessee is the owner of and has been granted an Oil and Gas Lease by the United States of America, dated Aug. 1, 19 60

NOW, Therefore, in consideration of the premises and the sum of One Dollars, and other valuable consideration, receipt whereof is

hereby acknowledged, the undersigned, Lessee, hereby sells, conveys, transfers, assigns and sets over unto Assignee, their heirs and assigns, an overriding

royalty interest of one and one-half percent (1 $\frac{1}{2}$ %) of 100% each as their separate property of all of the Oil and Gas and other hydrocarbon substances in place and which may be produced, saved and marketed from said lands, free and clear of all costs or expense to Assignee.

This Overriding Royalty Assignment shall be subject to those zones from the surface to the base of the so-called Granite Wash Section which shall be defined as that zone down to and including the base of the zone penetrated at the depths shown in the following wells: 3,275' Pacific Natural Gas Exploration No. 14-28-2 well located in Section 28, T36N R109W; and 2600' Skinner No. 5 Gov't Well located in Section 29, T36N R109W; and the stratigraphic equivalent of said zone.

The provisions hereof shall inure to and be binding upon the parties hereto, their heirs, assigns, personal representative and successors, and said overriding royalty interest herein reserved to Assignee shall run with said leasehold and all renewals and extensions thereof and all preference-right and substitute leases granted thereon, whether under said serial number or a new serial number, and whether issued to Lessee or Lessee's successors or assigns.


